With reference to the earlier announcements on the quarterly results for the quarter ended 30 April 2018 made on 25 June 2018, there were amendments made for the following:-

- 1) under the item 6 of the Summary of Key Financial Information, the Proposed/Declared dividend per share (Subunit) under the current year to date for cumulative period ended 30 April 2018 should be "2.4" instead of "1.6".
- 2) under the Note 9 to the Notes to the Interim Financial Report, the total net dividend per share paid to date for the current financial year should be 2.40 sen instead of 1.60 sen (2017: 2.40 sen).
- 3) under the Note 24 to the Notes to the Interim Financial Report, the total net dividend per share declared to date for the current financial year should be 2.40 sen instead of 1.60 sen (2017: 2.40 sen).
